**Water Improvement Ready-To-Serve Charge**

Debt retirement charges for the \$5.6 million water improvement 20-year bonds are levied at 5.32 mills on property taxes. Properties exempt from taxes shall be charged consumption ratio ready-to-serve charges as follows:

3/4" \$	25.51
1" \$	215.24
1 1/2" \$	220.47
2" \$	860.46
3" \$	180.82
4" \$	374.11

**Non-Registering Meters**

The consumption charge shall be based on usage from the same quarter of the prior year. If that figure is not available, then the average of the three (3) prior quarters shall be used. If no prior quarters are available, or if these quarters were in error, then the consumption charge shall be based on a minimum of ten (10) units of usage. A written notice of the non-registering meter will be sent to the property owner and/or resident requesting that they contact the Utility Billing Clerk for an appointment to correct the problem. If the customer fails to respond to the written notification, the consumption charge (non-refundable) on subsequent billings will be based on the account's highest recorded quarterly usage or on twenty (20) units (whichever is higher) and increase by 10 units for each billing thereafter until the problem is resolved.
