## **CARROLLTON TOWNSHIP HELPFUL TIPS TO FOLLOWING ORDINANCES**

**Nuisance-Grass, Sec. 62-22** grass in excess of eight inches in height to be a common nuisance on such residential and business parcels

**No parking on front lawn, Carrollton Township Zoning Ordinance, Section 66-167 (4)** which states: "No portion of a residential front lawn area may be used for parking."

**Unlawful Noise, Ordinance Section 22-22**

Carrollton Township has a noise ordinance that makes it unlawful to operate noise producing instruments, sound amplifying equipment and devices such as radios, phonographs or stereo equipment in such a manner as to disturb the peace of a neighborhood. It is also unlawful to operate an excessively noisy motor vehicle or motorcycle.

**Recreational Fires, The International Fire Code, Section 307.3.2** Bonfires and recreational fires shall be extinguished by 12:30 a.m. A responsible adult, at least 18 years of age, shall be present at all times until extinguished ashes are cold. A garden hose connected to a water supply or other extinguishing equipment shall be readily available for use at all burning sites.

**Family, Ordinance Section 66-32**

Carrollton Township has an ordinance that no more than 2 unrelated persons can reside in a single family dwelling
