Township Board Adopts Fiscal Year 2021-2022 Budgets

Rates for service were established for Carrollton Township's fiscal year which began April 1, 2021 and continues thru March 31, 2022. Fees, rates and tax collections provide the financial resources that allow the Township to provide services to our 6,103 citizens.

- The **General Fund** operates on a millage levy of **0.9100** along with State Shared Revenue
- The **Police Fund** operates on a millage levy of **8.9500** - this is 0.25 *less* than last year
- The **Fire Fund** operates on a millage levy of **3.0000** - this is 0.25 *more* than last year
- The **Municipal Street Fund** operates on a millage levy of **4.9815** - this millage was voted in by the citizens of Carrollton Township on March 10, 2020
- The **Garbage/Recycling Collection Fund** is funded thru a special assessment on your Winter Property Tax bill. **The 2021 amount will be \$185.00** - this is the same as last year
- **Water & Sewer Rates:** Your quarterly water/sewer bill is billed in units. One unit = 1,000 gallons. The water rate is \$5.43 per unit and the sewer rate is \$9.85 per unit. The Water Ready-To-Serve charge is set at \$15.00 per quarter and the Sewer Ready-To-Serve charge is \$15.25 per quarter. The Sewer Debt Ready-To-Serve charge is \$6.12 per quarter.

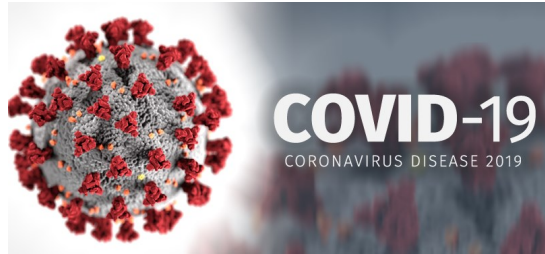


Please use the Drive-Up Dropbox located in the front parking lot for water/sewer bill payments, license/permit fees and correspondence.

****New Food Vendor Ordinance Approved****

At their regularly scheduled meeting held Monday, April 12, 2021, the Carrollton Township Board of Trustees adopted Ordinance No. 2021-01 - FOOD VENDORS. This ordinance allows for licensed food vendors to operate in Carrollton Township as individuals, a mobile restaurant or temporary food establishment. Food Vendor applications for 14 - 30 days are \$25.00 and annual permits are \$150.00. Food Vendor applications and the complete ordinance language are located on our website at **www.carrolltontwp.com**

You must have property owner consent to locate your food establishment. No parking on public streets, public parks, or any other public property except with the permission of the Township Director. Call 754-4611 for more info!
